Agenda topic No PARCCing | Presenter Catherine Francis & Melissa Bullock

- ISATs have been replaced by the PARCC test as Illinois' statewide test for 3rd-8th graders. Our students will not take the ISATs this year. They may or may not take the PARCC test in March and May.
- The PARCC test was developed by a company called Pearson, who are also responsible for most years of the ISAT. Illinois selected the ISAT and now the PARCC test to fulfill its federal obligation to federally funded initiatives No Child Left Behind and Race To The Top. The states were given money to adopt this new test. Illinois only received \$42 million for administering this test which is less than 1% of the state's education budget. To administer the test will cost Illinois \$160 million over 4 years! Pearson is a for profit company that needs a certain number of states to take their test to maintain their no bid contract with the federal government. They need students to take the test to make money.
- There has been a general uproar over the PARCC test: not field tested, confusing logistics for a computer
 test, very high fail rate, no special considerations for diverse learners, only given in English, not validated
 as an accurate assessment of common core, takes away 10 days of instructional time, and the list goes on.

- The PARCC will NOT be used by CPS for 2014-15 to determine student promotion, student acceptance to selective enrollment schools, principal/teacher evaluation, or school quality ratings. The scores simply do not matter to us as parents of students in CPS.
- The CPS Board does not want to give its students the PARCC test for this school year. They have requested to the Illinois State Board of Education to be exempt. The ISBE has denied the CPS board's request. The CPS board has in turn announced that only 10% of CPS schools will administer the test. At the moment, ISBE is determining if they are going to sanction CPS.

• WHAT DOES THIS MEAN FOR YOUR BLAINE STUDENT?

- o There is a chance that Blaine will not be chosen to administer the PARCC test. We don't know yet what schools will be selected.
- o If we do get selected, you can still, as a parent, opt out your student from taking the PARCC. The goal of the PTA is to get 100% of students to opt out so students get regular instruction.
- We may not know if Blaine will be selected until the very last minute. The PTA is collecting opt out signatures starting today. Should we be selected; we will be prepared. If we are not selected we will shred the letters.
- o If you do not want your student to take the PARCC, then sign an opt out letter today! The opt out letter requests reason code 15 be recorded for your student so that neither Blaine nor your student is penalized for the refusal.
